I must receive them by November 6th in order to complete the Annual Recharter process on time.

The Council Office has changed the Recharter dates. The Recharter for 2006 was submitted in January, and fees covered March 06 through February 07. The Council Office is moving the registration period for all troops to a January – December schedule. This year I must submit the Recharter in November and the fees will be good through December 07. Since we have already paid for registration through February 07, the fees for this coming year will be prorated to cover just March 07 through December 07.
